





### Schematic & PIN Configuration







Figure 1: Peak Pulse Power vs. Pulse Time





Figure 3: Clamping Voltage vs. Peak Pulse Current








Figure 2: Power Derating Curve




Figure 4: Normalized Junction Capacitance vs. Reverse Voltage






Figure 6: TLP I-V Curve










#### **Quadrant Assignments For PIN1 Orientation In Tape**
