



## **Schematic & PIN Configuration**





Figure 1: Peak Pulse Power vs. Pulse Time




Figure 3: Clamping Voltage vs. Peak Pulse Current




Figure 5: 8/20µs Pulse Waveform




Figure 2: Power Derating Curve




Figure 4: Normalized Junction Capacitance vs. Reverse Voltage






Figure 6: TLP I-V Curve




