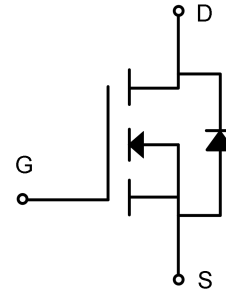

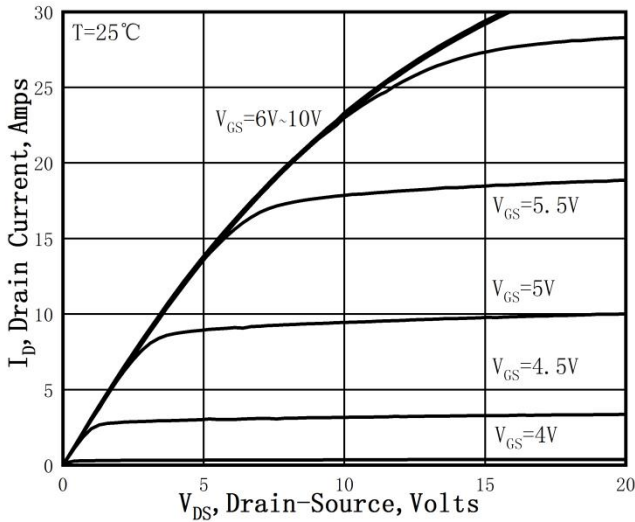


Figure 1. On-Region Characteristics

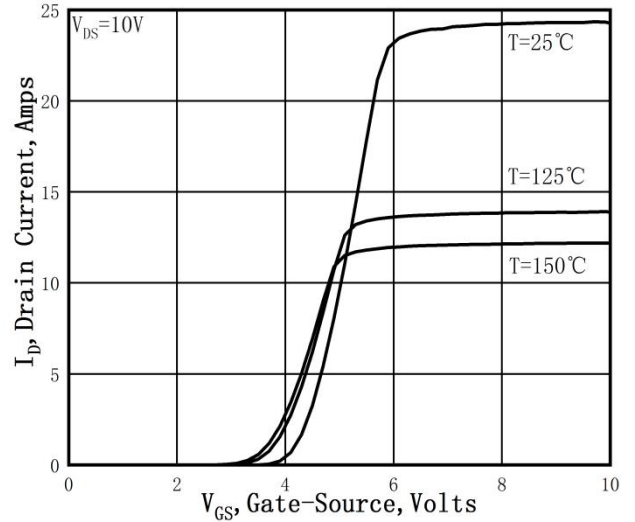


Figure 2. Transfer Characteristics

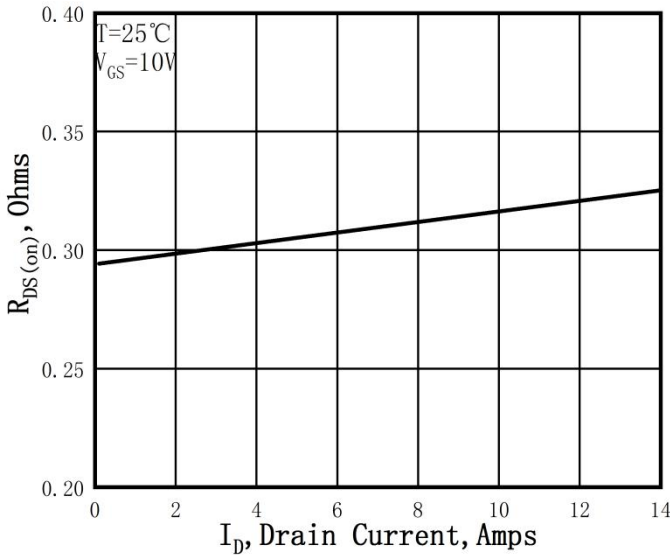


Figure 3. Static Drain-Source On Resistance

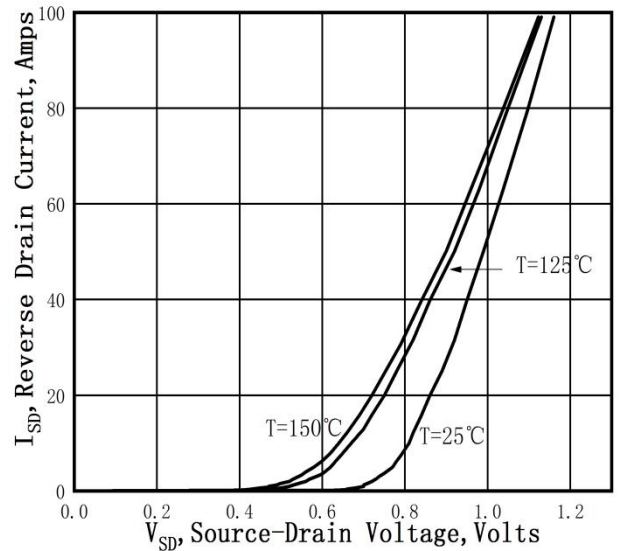


Figure 4. Typical Body Diode Transfer Characteristics

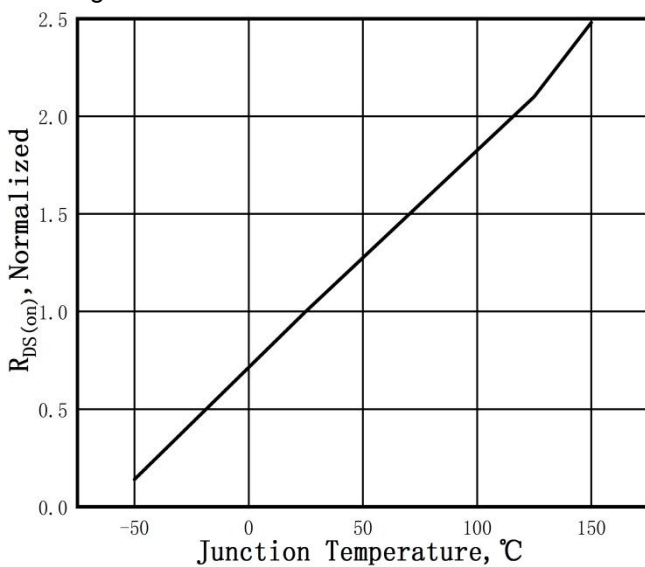


Figure 5. Normalized  $R_{DS(on)}$  vs. Temperature

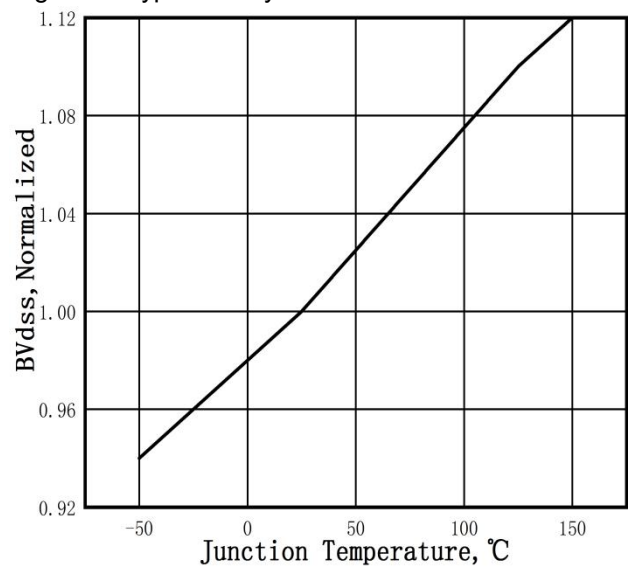


Figure 6. Normalized  $BV_{DSS}$  vs. Temperature

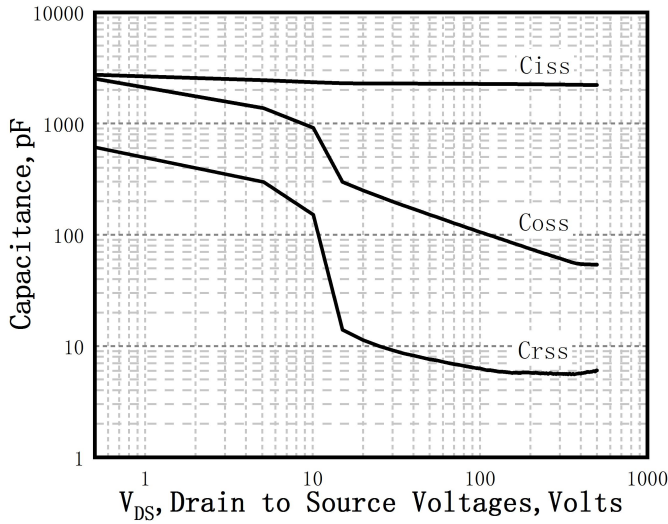


Figure 7. Capacitance Characteristics

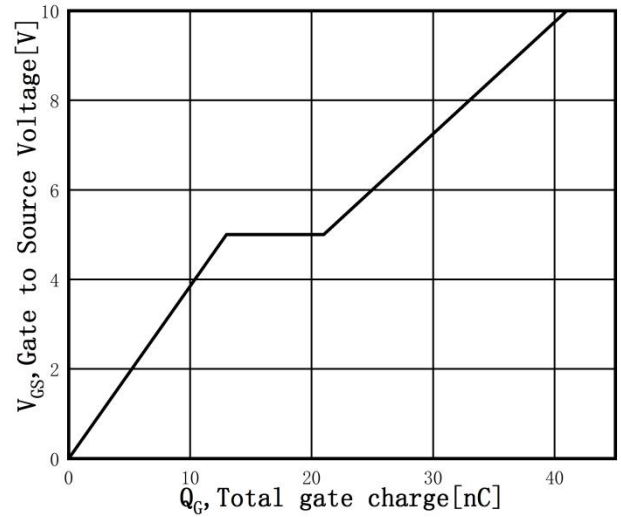


Figure 8. Gate Charge Characteristics

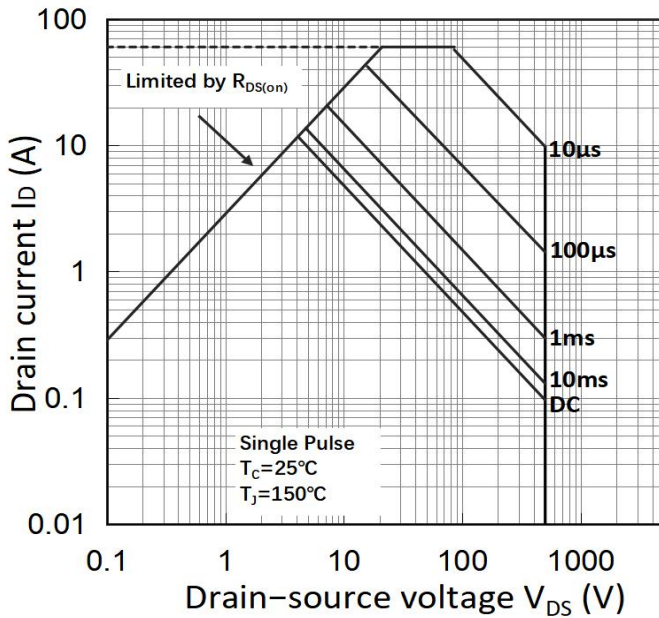


Figure 9. Maximum Safe Operating Area (TO-220F)

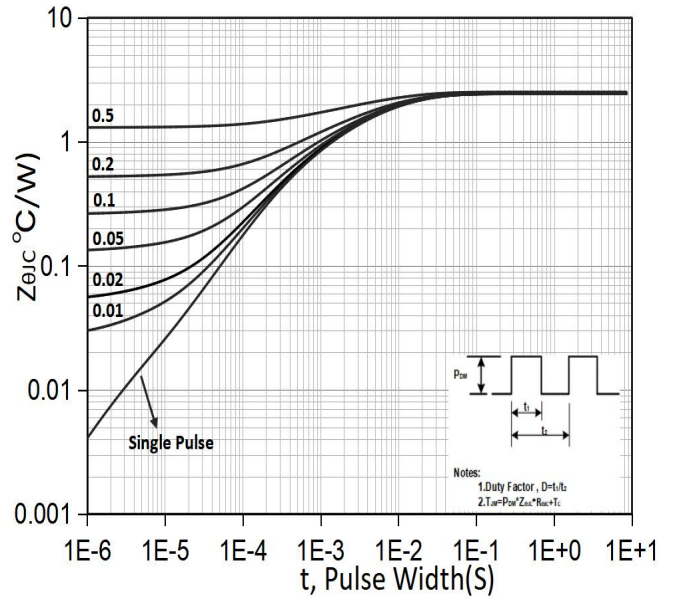
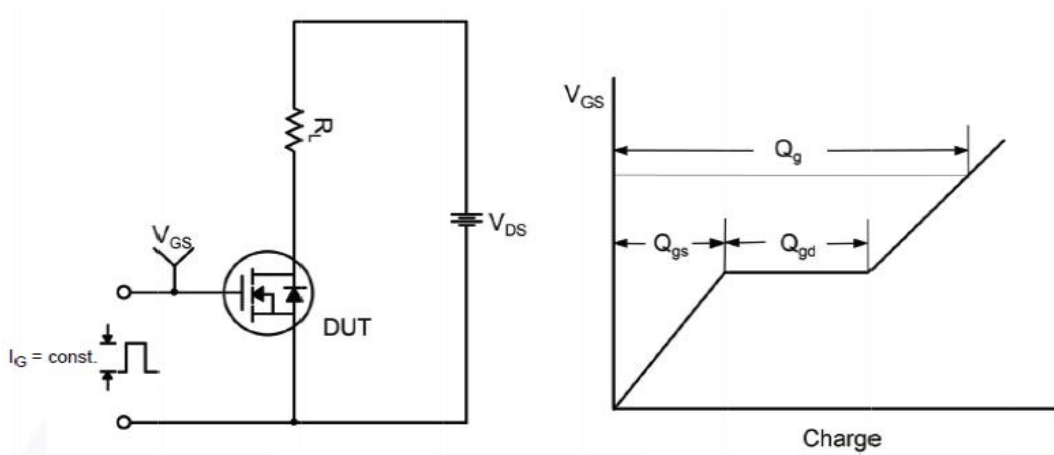


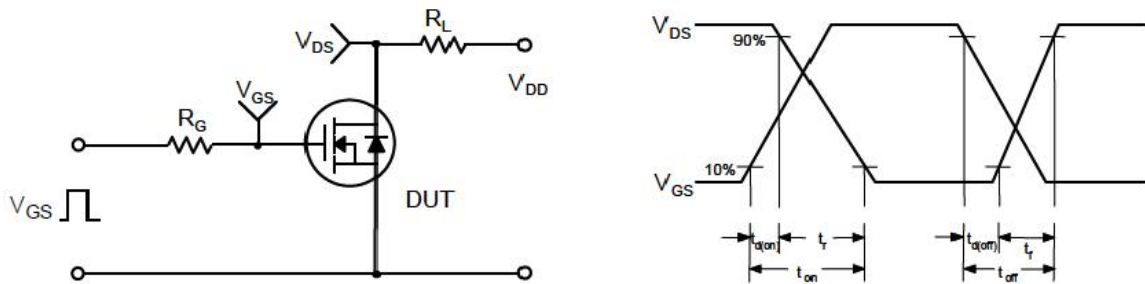
Figure 10. Transient Thermal Response Curve (TO-220F)

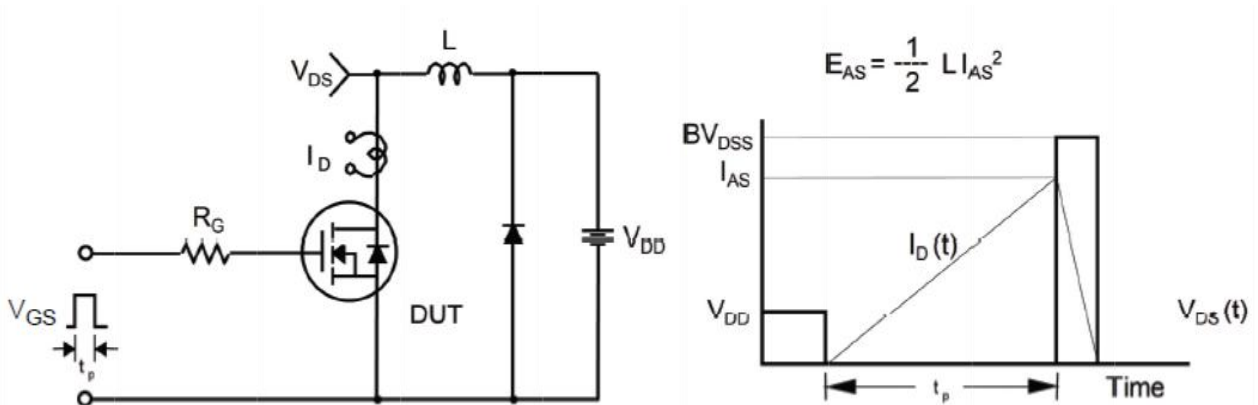
Gate Charge Test Circuit & Waveform



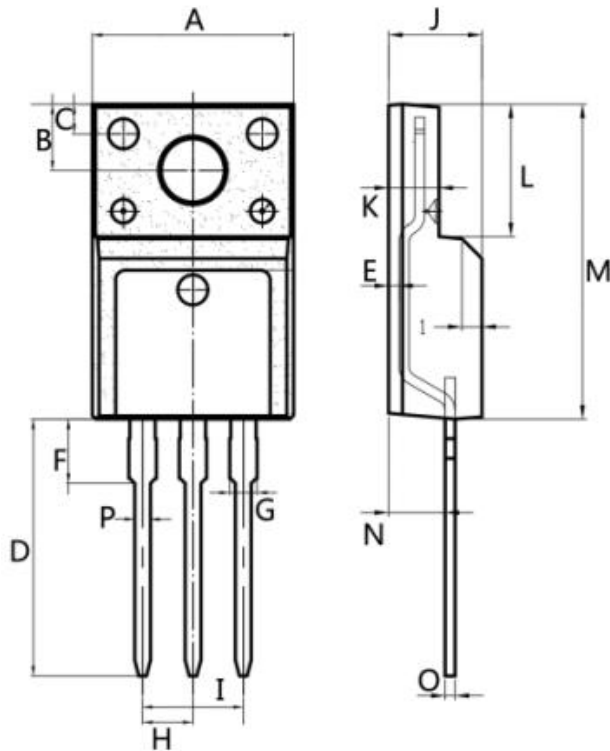
Switching Test Circuit & Waveforms
