




Figure 1.On-Region Characteristics




Figure 3. Static Drain-Source On Resistance




Figure 5. Normalized  $R_{DS(on)}$  vs. Temperature




Figure 2. Transfer Characteristics




Figure 4. Typical Body Diode Transfer Characteristics




Figure 6. Normalized BV<sub>DSS</sub> vs.Temperature






Figure 7. Capacitance Characteristics




Figure 8. Gate Charge Characteristics




Figure 9. Maximum Safe Operating Area





Figure 10. Transient Thermal Response Curve








## Unclamped Inductive Switching Test Circuit &Waveforms
