



Fig.1 Relative Current Transfer Ratio vs. Forward Current




Fig.3 Collector Current vs. Collector-emitter Voltage




Fig.5 Collector-emitter Saturation Voltage vs. Ambient Temperature




Fig.2 Forward Current vs. Forward Voltage




Fig.4 Relative Current Transfer Ratio vs.Ambient Temperature




Fig.6 Collector Dark Current vs Ambient Temperature




Fig.7 Response Time vs. Load Resistance




Fig.9 Collector-emitter Saturation Voltage vs Forward Current




Fig.8 Frequency Response








Fig.10 Switching Time Test Circuit & Waveforms







Soldering with hand soldering iron






