





Figure 1: Peak Pulse Power Vs Pulse Time




Figure 2: Power Derating Curve




Figure 3: Clamping Voltage vs. Peak Pulse Current




Figure 4: Normalized Junction Capacitance vs. Reverse Voltage




Figure 5: TLP Positive I-V Curve






Figure 6: TLP Negative I-V Curve








Reel Dimensions





Quadrant Assignments For PIN1 Orientation In Tape


