




Figure 1.On-Region Characteristics




Figure 3. Static Drain-Source On Resistance




Figure 5. Normalized R<sub>DS(on)</sub> vs.Temperature




Figure 2. Transfer Characteristics




Figure 4. Typical Body Diode Transfer
Characteristics




Figure 6. Normalized BV<sub>DSS</sub> vs.Temperature








Figure 7. Capacitance Characteristics




Figure 8. Gate Charge Characteristics




Figure 9. Maximum Safe Operating Area




Figure 10. Transient Thermal Response Curve




Figure 11. Maximum Safe Operating Area (TO-220F)




Figure 12. Transient Thermal Response Curve (TO-220F)






Figure 13. Maximum Safe Operating Area (TO-252)


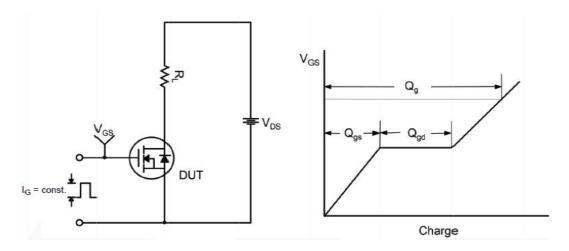


Figure 14. Transient Thermal Response Curve (TO-252)




## Gate Charge Test Circuit &Waveform




## Unclamped Inductive Switching Test Circuit &Waveforms






