




Figure 1.On-Region Characteristics




Figure 3. Static Drain-Source On Resistance




Figure 5. Normalized R_{DS(on)} vs.Temperature




Figure 2. Transfer Characteristics




Figure 4. Typical Body Diode Transfer Characteristics




Figure 6. Normalized BV_{DSS} vs.Temperature




Figure 7. Capacitance Characteristics




Figure 9. Maximum Safe Operating Area (TO-220/TO-263)




Figure 11. Maximum Safe Operating Area (TO-220F)




Figure 8. Gate Charge Characteristics




Figure 10. Transient Thermal Response Curve (TO-220/TO-263)





Figure 12. Transient Thermal Response Curve (TO-220F)




Gate Charge Test Circuit &Waveform



Switching Test Circuit &Waveforms




Unclamped Inductive Switching Test Circuit &Waveforms








